

# **Controller Options**

All luminaires are produced to control with PWM as standard. Other control options, determined on center of power that the luminaires are connected on.

### **Mounting Method**

- **REMARK:** When taking delivery of your product, be sure to check if there is physical damage. For the change of defected products, contact your dealer within 7 days from the date of purchase.
- REMARK: When taking delivery of your product you should be sure if your product is complete with accessories.
- **REMARK:** Please store your product's original box or package, accessories, bill, etc... for possible usage by the service.
- REMARK: Make sure not to damage the model number, product's barcode and serial number. If they are unreadable or worn out, your product's warranty will be void.
- **WARNING:** The products must be used within their intended use.
- REMARK: Manufacturer is not responsible for the injury or damage caused by the improper use of the product.
- WARNING: Electrical connections must only be carried out by qualified personnel.
- WARNING: Disconnect all electrical power from the electrical cables before

- REMARK: Additional apparatus which is determined by our company must be used for mounting.
  - For example: screws, clamps, terminals  $\dots$

- **WARNING:** The product should not be used while its top is covered.
- WARNING: This product should only be installed on non-combustible material.
- WARNING: Cable ports must be insulated with connection terminals or melting tape.




### Mounting

There are three different mounting methods on the floor


- 1) Connection to profiles or pole with clamp

- 3) Mounted embedded to floor with mounting stake on loose surfaces





# **Cable Connection**




# **Underwater Addition Muffs**
