

Personal Data Protection Law (PDPL)

In accordance with Article 10 titled 'Obligation of Data Controller to Inform' of the Personal Data Protection Law No. 6698 ("Law"), published in the Official Gazette dated April 7, 2016, No. 29677, and the Communiqué on the Principles and Procedures to be Followed in the Fulfillment of the Obligation to Inform, published in the Official Gazette dated March 10, 2018, No. 30356, this Disclosure Text aims to inform you about your personal data processed by PSL Elektronik and its subsidiaries (Fiberli, Tecolight, Growlight, hereinafter collectively referred to as PSL Elektronik) as the Data Controller. PSL Elektronik takes all necessary technical and administrative measures to ensure an appropriate level of security to prevent unlawful processing, access, and preservation of your personal data.

Processed Personal Data

Identity Information : Name, surname, ID number, place and date of birth, marital status, gender, ID serial and sequence number, nationality, passport number, parents' name, mother's maiden name, photograph, ID sample.

Contact Information : Phone/fax number, e-mail address, address information.

Purposes of Processing Personal Data

Your personal data may be processed for the following purposes in accordance with the processing conditions specified in Articles 5 and 6 of the Law and secondary regulations:

- Providing customer services, meeting customer complaints/requests, fulfilling all contractual conditions in this regard,
- Conducting survey/analysis studies focused on measuring customer satisfaction, researching customer trends and improving service quality,
- Offering prize/sweepstakes/competition/gift/thank you/celebration/reminder practices focused on ensuring customer satisfaction,
- Providing information about the preparation, presentation, promotion, follow-up and reporting of campaigns and offers regarding products and services according to the use of our customers,
- Sharing information/documents requested by regulatory and supervisory bodies and official authorities, fulfilling legal obligations under the relevant legislation and conducting audit activities,
- Legal follow-up and execution of legal processes.

Transfer of Personal Data

Your personal data may be transferred to the following 3rd parties within the scope of the Laws and other legislation and within the scope of the provisions of the Law regarding the transfer of personal data domestically and abroad for the purposes described:

- Under the roof of PSL Elektronik, Growlight, Fiberli, Gara İnş. Tecolight companies,
- Companies, representatives, dealers that we have authorized, operating on behalf and account of our Company,
- Your attorneys, guardians and representatives authorized by you.

Methods and Legal Grounds for Collection of Personal Data

Your personal data; Although it varies according to the nature of service, product and activity, it can be obtained and processed through companies operating on behalf and account of our company, our representatives, dealers, our website, call center and mobile applications that we have authorized.

Your personal data are collected from you, third parties and legal authorities during the establishment of your legal relationship with our Company and during the continuation of the said relationship, via internet, telephone, e-mail, voice response, text message; from physical, written, verbal and electronic media for the purpose stated above and for the purpose of providing services within the framework stipulated in the provisions of Articles 5, 6 and 8 of the Law written below, by fully / partially automatic or non-automatic means. Your personal data are processed based on the following legal grounds:

- To comply with the principles and principles in the national and international arena regarding the recognition of customers, to comply with the information storage, reporting and information obligations stipulated by the legislation and official authorities,
- Your explicit consent,
- Processing of personal data of the parties to a contract is necessary, provided that it is directly related to the establishment or performance of the contract, in order to provide the requested products and services and to fulfill the requirements of the contracts you have concluded,
- It is mandatory for the fulfillment of the legal obligation,
- Personal data have been made public by the data subject himself/herself,
- Data processing is necessary for the establishment, exercise or protection of any right,
- Processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject,
- In cases of physical disability, where you are unable to explain your consent or if the consent of the person whose legal validity is not recognized is required to protect the life or physical integrity of themselves or another person,

Contacting for your Rights and Requests;

Pursuant to Article 11 of the Law regulating the rights of the person concerned, you can submit your requests with a petition organized in accordance with the conditions specified in the Communiqué On The Principles And Procedures For The Request To Data Controller in order to determine whether the application belongs to you by PSL Elektronik according to its nature and your application method and thus to protect your rights:

- You can deliver it directly to our addresses given below regarding the relevant channel by hand, by mail or through a notary public,

The applications to be made within this scope will be accepted following the identity verification to be made by us, and your requests will be finalized as soon as possible and within 30 days at the latest, depending on the nature of the request.

Cookie Policy

When you use the Fiberli website, we and third parties, using 'cookies' and other technologies, may collect some information in the nature of non-personal data (Cookies) so that you can use the tools we offer you.

Please click on the Cookie Confirmation Bar to see a list of companies that use cookies and how they use them. This tool is always available in the bottom corner of our website. When you visit our Fiberli websites, you give your consent to third parties who use cookies to navigate the site or use cookies in accordance with us and your cookie settings in line with your cookie settings. You can use the Cookie Confirmation Bar to change your preferences at any time.

What is a Cookie?

A cookie is a small text file that contains small amounts of information and transfers this information to your computer via your internet browser. So the website can remember who you are. The length of time a cookie stays on your computer depends on whether it is a persistent or session cookie. Session cookies are temporary cookies that remain on your computer until you leave the website. Persistent cookies remain on your computer after scanning is finished until they expire or are deleted. A pixel tag, or sometimes an internet beacon, is an invisible image with a string of codes that is embedded in an e-mail message or a web page. Cookies can be categorized as "First Party Cookies" or "Third Party Cookies". "First Party Cookies" are cookies placed on your device by Ticketmaster / Live Nation, while "Third Party Cookies" are cookies that another party controls but are placed on your device when you visit our site. For example, we use Google Analytics cookies to collect information about the user experience on our Fiberli website.

What are cookies used for?

Cookies can be placed in one of the following categories, such as "essential cookies", "analytical cookies", "functionality cookies" and "advertising and marketing cookies". The table below provides detailed information about each category:

Essential Cookies

These cookies are necessary for the Fiberli website to work. They allow you to move around the website and use its features. Without these cookies, necessary services such as access to secure areas cannot be provided.

Methods of Collection of Personal Data and Legal Reasons

These cookies collect information about how the website is used, which pages are visited most frequently and how to move from one link to another. The information collected on the Fiberli website is grouped together with other people's use of the fiberli website in aggregate.

Functionality Cookies

Cookies allow us to remember choices you make and to tailor the Fiberli website to offer you enhanced features and content. For example, these cookies may be used to remember your username (not your password). They may also be used to remember changes you make to text size, font and other parts of the pages that you can customize.

How do you manage cookies on Fiberli website?

In addition to the Cookie Consent Bar, most browsers allow you to manage your cookie preferences. The browser notifies you when you receive a new cookie or when you use it to disable cookies completely. If you decide to completely disable or delete them, some sites do

not rely on cookies to provide you with the service you have requested, nor do they work. If you do not want to allow Fiberli and third parties to use cookies such as pixel tags within emails, the best way to do this is to not enable images when you view our emails. In other words, only view the plain text of the email. Some internet browsers and email clients can be used to disable/block cookies, such as Gmail.
